PARENT / GUARDIAN RELEASE • FOR A CHILD UNDER 18

Minor Photography & Video Release and Liability Waiver

To be signed by the parent or legal guardian of a child under 18. Please read before signing. This explains how Dot One Media may use images and video of your child, and the terms that apply to the session.

In plain terms: Because your child is under 18, only you, as the parent or legal guardian, can give permission. By signing, you allow Dot One LLC (doing business as Dot One Media) to photograph and film your child and to use that content according to the option you choose below. You also agree, on your child's behalf, to the participation and liability terms for the session. Please read the full agreement, ask any questions, and keep a copy for your records.

1 Parties, Child & Authority to Sign

This Minor Photography and Video Release and Liability Waiver (this "Agreement") is entered into between **Dot One LLC**, an Alaska limited liability company doing business as Dot One Media ("Dot One Media," "we," or "us"), and the parent or legal guardian signing below ("you"), on behalf of the minor child identified below (the "Child").

1.1 Confirmation of Authority. You confirm that **you are the parent or legal guardian of the Child, that the Child is under 18 years of age, and that you have full legal authority to grant the permissions and agree to the terms in this Agreement on the Child's behalf.** If custody or guardianship is shared, you confirm you are authorized to sign on behalf of all who share it.

2 Grant of Rights & Consent

2.1 Consent to Capture. You consent, on behalf of the Child, to the Child being photographed, recorded, and filmed by Dot One Media (the "Content"), including the capture of the Child's name, likeness, image, voice, and appearance.

2.2 Ownership. You acknowledge that Dot One Media owns all rights, including copyright, in the Content it creates, and that neither you nor the Child has any ownership interest in the

Content. This is standard in professional photography and video: the creator owns the work product.

2.3 Scope of Use. You grant Dot One Media the right to use, edit, reproduce, publish, and display the Content according to the **usage option you select in Section 3 below**. Dot One Media may make ordinary edits such as cropping, color correction, retouching, and formatting, but will not depict the Child in a knowingly false, defamatory, or misleading manner.

3 Your Usage Choice

Choose one. This controls how images and video of your Child may be used. If none is selected, Option A applies by default. Many parents choose Option C for a child.

- ☐ **Option A: Portfolio & Marketing.** Dot One Media may use the Content to promote its own business, including its website, social media, online portfolio, printed samples, award and competition entries, and its own advertising. Dot One Media will **not** sell or license the images to unrelated third parties for their own advertising.
- ☐ **Option B: Full Commercial Use.** In addition to Option A, Dot One Media may license, sell, or assign the Content to third parties and use it for commercial purposes, including client campaigns and paid advertising, without further compensation. *(Typical only for commissioned commercial projects involving a child model.)*
- ☐ **Option C: Private / Limited Use.** Dot One Media may use the Content only to deliver your finished project to you and may **not** publish or use the Child's images publicly, except:

4 Name & Identification

Dot One Media will not publish the Child's full name, school, or identifying personal details in connection with public uses of the Content without your separate permission. Where the Child is identified at all in permitted uses, Dot One Media will use only a first name or no name, consistent with the usage option you selected and ordinary child-safety practice.

5 No Approval Rights; Consideration

5.1 No Pre-Approval. You waive any right to inspect or approve the finished Content or the specific uses Dot One Media makes of it within the scope you selected, so we can apply our professional judgment in editing and presentation.

5.2 Consideration. You acknowledge that the session, the services provided, and/or the images delivered are full and adequate consideration for the rights granted, and that neither you nor the Child is entitled to any additional payment, royalty, or accounting for permitted uses of the Content.

6 Voluntary Participation & Assumption of Risk

You acknowledge that the Child's participation is voluntary and that you have chosen to allow it. You understand that photography and video sessions may involve ordinary risks, including movement around a set or location, equipment, cabling, lighting, props, and outdoor or travel conditions. **You agree to supervise your Child as appropriate and to remain responsible for the Child's conduct and safety during the session.** You agree to follow, and to help the Child follow, reasonable safety instructions.

7 Release & Limitation of Liability

7.1 Release of Claims. To the fullest extent permitted by law, you, on behalf of yourself and the Child, release and hold harmless Dot One Media and its owner, employees, and agents from any claims, demands, or liability arising out of or related to the creation of the Content and the permitted uses of it, including any claim of defamation, invasion of privacy, right of publicity, or emotional distress, based on uses within the scope you authorized.

7.2 Limitation of Liability. To the fullest extent permitted by law, Dot One Media's total liability arising out of or related to the session or this Agreement shall not exceed the total amount paid to Dot One Media for the applicable session. Dot One Media shall not be liable for indirect, incidental, or consequential damages.

7.3 Personal Belongings. Dot One Media is not responsible for loss of or damage to personal property during a session except to the extent caused by its own gross negligence or willful misconduct.

Note: some claims belonging to a minor cannot be fully waived by a parent under applicable law. This release is intended to be enforced to the fullest extent the law allows.

8 Your Representations & Indemnification

8.1 Representations. You represent that you are the parent or legal guardian with authority to sign, that you are free to grant the rights in this Agreement, and that any wardrobe, props, or materials you or the Child bring do not infringe anyone's rights.

8.2 Indemnification. To the fullest extent permitted by law, you agree to indemnify and hold Dot One Media harmless from any third-party claim, loss, or expense (including reasonable attorney's fees) arising from a breach of your representations above, from a dispute over authority or custody to grant these permissions, or from the Child's conduct during the session.

9 General Terms

9.1 Binding Effect. This Agreement is binding upon you, the Child, and your and the Child's heirs, successors, and assigns, and the rights granted are irrevocable and perpetual within the scope you selected.

9.2 Governing Law. This Agreement is governed by the laws of the **State of Alaska**, without regard to its conflict-of-laws principles. Any dispute shall be brought in the state or federal courts located in Alaska.

9.3 Severability & Entire Agreement. If any provision is held unenforceable, the remaining provisions remain in effect, and the unenforceable provision shall be enforced to the maximum extent permitted. This Agreement is the entire agreement between you and Dot One Media regarding its subject matter and supersedes any prior understandings. Any changes must be in writing and signed by both parties.

9.4 Acknowledgment. You confirm that you have read this Agreement, understand it, have had the opportunity to ask questions, and sign it voluntarily as the parent or legal guardian of the Child.
